

Hearing Sunday's Scriptures as a Community, August 6, 2023

This column applies Sunday's scriptures to the life of our parish (or other community) as a community. As a parish in another major transition, we should find in Scripture some models of how God's earliest communities let the Word of God form them. They coped with big changes, they wanted to remain faithful and hopeful, they had to distinguish good plans from bad ones. So do we.

Your Evangelization Team asked parishioner Greg Warnusz to contribute these from his ongoing, online work.

Keep it public, keep it honest.

Sunday's passage in the Book of Daniel is an example of what's called apocalyptic literature (from the Greek word meaning "unveiling" or "revealing"). Apocalyptic emphasizes the disclosure of secrets to insiders, who usually feel persecuted by outsiders. The revealing uses the medium of angels, visions and bizarre symbolism. In the Book of Daniel, the special revelations in chapters 7-12 take the form of resistance literature. It encouraged those experiencing persecution to persevere because the end of the time of tribulation was at hand. In today's passage, The Ancient One (in other translations, The Ancient of Days) holds court in heaven. There comes before the Ancient One a human person (a "son of humanity"), who receives sovereignty, glory, and the loyalty of peoples of all nations.

This is resistance literature, of course, because the son of humanity is expected to oust Israel's current occupiers, the Greek conquerors trying to make Jews abandon their religion.

One theological reflection: In apocalyptic, the description of how God is intervening arrives in a mystical vision. That's what convinced the ancients it was from God. But the **content** of the vision is that a recognizably human person is God's agent of intervention. We may separate the message from the medium. We may conclude that God may use recognizably human messengers to intervene in our planning and in our coping with the unplanned.

- Who has played the prophet Daniel in your community's history, identifying the agent of change?
- Who has played the Son of Humanity in that history, executing a saving change?

- What outside pressure is your community resisting?
- If your community has nothing to resist, what does that tell you?
- Do you do anything that might earn you persecution, earn you criticism?
- Have you let yourselves be co-opted by those who would otherwise persecute you?

Some historians say that when the Roman emperor made friends with the early church, some Christians moved to the desert. They wanted to do spiritual battle there with the devil, in the absence of human persecutors.

- Does your community have this character?
- Has your community moved away from something grown comfortable and unchallenging?

Apocalyptic is traditionally written in all-or-nothing terms. That is, once the Son of Humanity appears on a cloud, it's ALL over, ALL OVER. But maybe some ideas from Daniel, or the Book of Revelation, can be applied to disruptions on a smaller scale.

- What disruptions has your community suffered, or caused, that can be described this way?
- The more conventional a community is (the more it conforms to surrounding communities) the less connected it is to End Times, to God's triumph, to all things new. Where is your community on that spectrum?
- There are good questions and better ones in your heart, too. Ask them in your community.



Dear Brothers and Sisters in Christ,

As we begin the implementation phase of All Things New, I wanted to make you aware of some circumstances affecting the implementation process. As you know, when we shared the decrees for All Things New on Pentecost weekend of this year, we outlined the canonical process by which an individual may seek recourse or appeal changes to the new structure of their parish.

Parishioners from seven parishes for whom there was a decree at Pentecost have requested to seek hierarchical recourse. The Office of Strategic Planning communicated the recourse earlier today to the incoming pastors of St. Angela Merici (Florissant), St. Catherine of Alexandria Parish (Coffman), St. Francis of Assisi Parish (Luebbering), St. Martin of Tours Parish (Lemay), St. Matthew the Apostle Parish (St. Louis), St. Richard Parish (Creve Coeur), and St. Roch Parish (St. Louis).

Out of respect for the canonical process and the recourse that is pending with the Dicastery for the Clergy, I have issued a decree which suspends the effects of the decrees on Pentecost and which makes temporary provision for the pastoral care of these seven parishes. These new decrees will be published soon on the Archdiocese website for All Things New: allthingsnew.archstl.org.

Please take a few moments to review the attached Q&A that contains more information and explanations for these new decrees. For further context, please check this link to read an article that will be published in the St. Louis Review's digital edition today and the August 7th print edition.

Again, I thank you for your engagement in this process, and I humbly ask for your prayers as we forge ahead.

DECREE

On May 24, 2023, I, the undersigned Most Reverend Mitchell T. Rozanski, Metropolitan Archbishop of Saint Louis, decreed the merging, (canon 121), of Saint Angela Merici Parish in Florissant, Missouri, into a newly erected parish bearing, *ad interim*, the name Holy Name of Jesus, Saint Angela Merici, and Saint Norbert Parish in Florissant, Missouri effective August 1, 2023. However, on July 22, 2023, recourse was made to the Apostolic See against my decree.

Accordingly, I suspend the execution of the aforementioned decree until this recourse before the Apostolic See has concluded (canon 1736 §2).

Moreover, I hereby appoint the Reverend Peter T. Faimega, Parochial Administrator of Saint Angela of Merici Parish (canon 539).

Anything to the contrary notwithstanding.

What is a decree suspending effects of a decree?

This means that the merger or suppression of the parish is put on hold until the resolution of the case by the Dicastery for the Clergy.

Why did Archbishop Rozanski decree a suspension of effects?

Archbishop Rozanski decided to suspend the effect of these decrees because he respects the fact that recourse is pending with the Dicastery for the Clergy, which will eventually render a decision regarding the case.

What does suspending effects mean on a practical level for a parish?

- Financial accounts should not be closed or merged if a suspension of effects is decreed.
- Finance Councils should not be dissolved or merged if a suspension of effects is decreed.
- Many parishes have created interim Mass schedules to offer a variety of Mass times to the faithful with a view of the number of priests assigned to the parishes. Suspending effects will not affect current or interim Mass schedules.
- Parish Pastoral Councils and advisory committees are able to work together where possible to mutually collaborate.
- A decree of suspending of effects will not affect upcoming school decisions.
- All of our parish communities are asked to re-evaluate their current pastoral care, social outreach and evangelization efforts to see how they can be improved.

How long will the suspension of effects be in place?

The merger or suppression of the parish will be put on hold until a decision is given by the Dicastery for the Clergy. This will likely take several months.

How long will it take for the Dicastery for the Clergy to make a decision on recourse?

While there is no timeline for the Dicastery for the Clergy to make a decision, it is likely that the process will take several months.

Is there a difference between a pastor and a parochial administrator?

A parochial administrator is a priest temporarily entrusted with the pastoral care of a parish under the authority of the diocesan bishop in whose ministry of Christ he has been called to share. The parochial administrator is bound by the same obligations and possesses the same rights as a pastor. As a temporary caretaker, a parochial administrator is not permitted to do anything which prejudices the rights of the pastor or can harm parish goods.

What does it mean "to do nothing which would prejudice the rights or the parish goods"?

The instruction means that the pastor should not make changes in parish life which would be difficult to reverse, such as combining the registration data of two parishes into a single database. The instruction also means that the pastor should not sell parish property. The instruction does not mean that the pastor should do nothing at all. The pastor should continue to make those changes which can be reversed if needed and those changes which fit with collaboration between two parishes.

How should a pastor respond if part of his parish has recourse?

A pastor should respect the fact that all the faithful can legitimately vindicate and defend their rights in the Church in the competent ecclesiastical forum according to the norm of the law.
